9/25/98 HAVE COMPLETED AUDIT WITH PALMETTO IN LAST QUARTER; PALMETTO CLAIMS FURTHER DEDUCTION OF OVER \$750K BECAUSE OF LACK OF DOCUMENTATION; HAVE HAD SEVERAL CONF. WITH TRACY KLUDING AND HCBS RE: THESE RECORDS; HAVE RECEIVED EXCELLENT DECISION IN HEALTHBACK CASE WHICH SHOULD HELP US PROCEED AGAINST PALMETTO ON OUR CLAIM; ISSUES OF PROOF OF DAMAGES AND EXHAUSTION OF ADMINISTRATIVE REMEDIES MAY REMAIN, AND OUR FOCUS AT THIS TIME IS ON THOSE ISSUES; CONTINUE TO RECEIVE FROM 20-80 PHONE CALLS PER MONTH ON PAYMENT; WAGE ISSUES, W-2 ISSUES FROM PRIOR EMPLOYEES. HEALTH INSURANCE ISSUES HAVE SLOWED DOWN; FBI HAS BACKED OUT OF PROTECTIVE ORDER AGAIN. HAD AGREED TO PAY RENT ON RECORDS, BUT NOW REFUSES; WANTS TO MOVE RECORDS TO FBI BUILDING; I HAVE DECLINED TO LET THEM OUT OF OUR POSSESSION, AND WILL TRY AND MOVE THEM BACK TO HCBS LOCATION.
